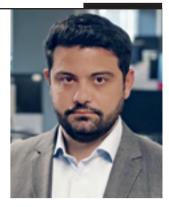

DIRECTOR'S DESK



As we welcome the summer, quite a few interesting situations are unfolding around us. On June 25, Greece is heading to the polls for the second time in two months to elect a new government—a new government that must, as I have often written, address a series of key issues beyond the economy, which, according to analysts, is expected to continue growing through 2023 and 2024, attracting the interest of institutional investors and multinational companies.

The crucial issue that must be prioritized is the reform and transformation of state governance. We need a state with strong institutions and a modern public administration that will ensure equalitarianism and provide the best services to all its citizens, in health, housing, education, and security to name but a few. A state with the capacity to see the world as it is, today and in the future, with the insight to understand what our country truly needs and has the potential to achieve, and with the determination to identify and implement the steps for getting there.

To be clear, by *state*, I am not only referring to the administration but to all of us who live and work in this country. We are all part of this state; we all have rights but also obligations. As the adage goes, "A state is nothing more than a reflection of its citizens; the more decent the citizens, the more decent the state"—whether with our participation or with our toleration.

The rapid development of technology and the way humankind assimilates and utilizes it will be the central issue at stake in the coming years. We are already witnessing technology's potential in transforming both the public and private sectors, and the pace at which we embrace and harness it will dictate the odds of competition and perhaps even survival. But it isn't only technology we must focus on.

We are, essentially, on the cusp of the Fifth Industrial Revolution (5IR), which encompasses at its core harmonious collaboration between humans and machines, be they digital platforms or advanced mechanical constructions. Such harmonious coexistence entails not only harnessing the potential of emerging technologies but also making special efforts to prioritize human values, ethics and wellbeing while doing so. It is a dynamic process that requires constant adaptation, evaluation, and collaboration to ensure that the benefits of 5IR are widely distributed and that human dignity and prosperity are preserved.

As these situations unfold, are we prepared to deal with what is coming? Are we addressing these issues as we should or not? Our Chamber, as always, will continue exploring these and other important issues in its upcoming activities. Stay tuned.

Bulgaria in the Eurozone – What's Next for Business?

The American-Hellenic Chamber of Commerce participated in the "Bulgaria in the Eurozone – What is Next for the Business" conference, which was organized by the American Chamber of Commerce in Bulgaria on April 5, 2023. The conference, which was held at the Grand Hotel Millennium Sofia, focused on Bulgaria's path toward adopting the single European currency, serving as a platform for AmCham Bulgaria to join the public debate, build constructive institutional dialogue, and contribute its insights into the business angle and its expectations in joining the eurozone.

Hosted by AmCham Bulgaria CEO Ivan Mihaylov, the conference was attended by Metodi Metodiev, Caretaker Deputy Minister of Finance of Bulgaria, and Dimitar Radev, Governor of Bulgarian National Bank, as well as the executive directors of Am-Cham Croatia, Andrea Doko Jelusic, and AmCham Greece, Elias Spirtounias. Addressing the conference, Spirtounias referred to Greece's experience of joining the eurozone and outlined the several benefits Bulgaria stood to enjoy, including lower inflation, higher levels of FDI, easier access to and operation in international markets, a boost to the country's credit rating, higher integration into financial markets and harmonization with regulatory frameworks, increased tourism, and greater political stability. "My country has admittedly benefited by entering into the eurozone, and I am sure Bulgaria would benefit as well," Spirtounias said. "In the end, you can learn from the experience of other countries such as Greece and Croatia and pave an easier path."

The American-Hellenic Chamber of Commerce, through its Education, Innovation and Entrepreneurship (EIE) Committee, proudly co-organized NBG Business Seeds' "Innovation in Northern Greece and the Bodies that Support It 4.0" event, which was held on May 4 and May 5, 2023, at OK!Thess in Thessaloniki. Featuring a total of 22 panels, 150 speakers and 10 workshops, the conference mapped out innovation in Northern Greece by addressing key questions, such as: What does innovation in Northern Greece mean today? Who can benefit? Which sectors of the economy are affect-

ed? Which organizations support the effort of teams and companies to innovate? What financial tools are there? What other forms of support are provided? What opportunities and challenges did the COVID pandemic create in Northern Greece?

Research teams and startups also had the chance to compete for prizes, while one company was shortlisted to participate directly in Phase II of the 14th Innovation and Technology Competition.

Focus on Skills

In the context of their memorandum of cooperation and following their recent survey on skills needed in the Greek jobs market, AmCham Greece and DYPA held a closed working breakfast with representatives of key sectors and industries to present and discuss the survey's findings.

he American-Hellenic Chamber of Commerce and the Greek Public Employment Service (DYPA) jointly organized a closed working breakfast, which took place on April 5, 2023, at the NJV Athens Plaza in the Greek capital. Participants-representatives of a wide range of industries and sectors including pharma, tourism and manufacturing-enjoyed the opportunity to find out and discuss the results of the most-in-demandskills survey recently jointly conducted by the two organizations. Opening remarks were delivered by Nikolaos Bakatselos, President of AmCham Greece, and Gianna Hormova, Deputy Director of DYPA, who noted the meaningful and ongoing cooperation between AmChamGR and DYPA and noted that DYPA is continuing to enhance and expand its vocational education, apprenticeships and on-the-job training programs to address the market's needs. The results of the survey were then presented by Andreas Siokos, Senior Data Analyst at OPAP, and the ensuing discussion was coordinated by Dr. Venetia Koussia, Chair of the Employment Committee of the American-Hellenic Chamber of Commerce.

Reflecting on the survey's results in an article written for newspaper Naftemporiki, Koussia stressed the vital importance of a suitably skilled workforce to business development and economic growth. Pointing out the multiple factors at play in Greece—from the infamous brain drain and foreign laborers returning to their

home countries to the disconnect between further education institutions and the job market and, of course, the country's inverted population pyramid and shrinking working-age cohort—she noted that according to the survey, employers are struggling to find suitable candidates for a significant number of positions across industries, including manufacturing (16%), management (15%), IT (13%), and sales and marketing (12%).

"Soft skills are clearly most important to businesses as well as workers, which is why they're often referred to as 'power skills'skills that empower us to change things, collaborate, manage situations, and utilize technology and our technical knowhow. Companies are looking for people with communication skills, capable of working in teams, problemsolving and eagerly adapting," Koussia wrote. Crucially, she pointed to the high demand (30%) for functional skills, noting that it "points to educational inadequacies (lack of reading comprehension, deficits in basic numeracy, and low numerical reasoning and statistical analysis abilities) and calls for an urgent return to the drawing board to redesign education across all levels, with a focus on creating the conditions for a better life for all those who will live and work, in the coming years, using technology on a daily basis." Going on to discuss the demand for technical knowhow and the lack of quality vocational and professional training, the article ended by bringing the focus back to what matters most: "Most businesses look to technology as a panacea against an uncertain future and forget that what's really missing is the human element," Koussia says. "What we need is people, and we can nurture more by becoming a job market focused on skills rather than job titles, which are becoming increasingly redundant." 👼

AEGEAN AND CAE IN JOINT VENTURE TO LAUNCH GREECE'S FIRST ADVANCED FLIGHT TRAINING CENTER



Aegean, Greece's largest airline, and CAE, the Canada-headquartered global leader in civil aviation training, have launched a joint venture to establish the first

advanced flight training center in Greece. The new Aegean CAE Flight Training Center will be part of Aegean's new technical base at Athens International Airport, a \in 140 million investment that was announced in December 2022, and will be powered by green energy thanks to the 35,000 m2 of photovoltaic panels embedded in Aegean's new hangar, which are set to generate 3 MW or 4.4 GWh of electricity annually.

Work on the new facility is already underway, with the first sections expected to be completed in September and operations expected to begin by the end of 2023. The Aegean CAE Flight Training Center will initially operate four full-flight simulators—including two Airbus A320neo, one Boeing 737NG, and one ATR 72-600—as well as cabin crew training equipment, and will have space for three additional full-flight simulators. At full capacity, the center will be able to train up to 3,500 pilots (42,000 pilot training hours) and many more cabin crew annually.

The new Flight Training Center will allow Aegean pilots and cabin crew to train in the country and will open additional training capacity for other airlines in the region. The venture will expand CAE's global training network and is integral to the creation of Aegean's aviation ecosystem in Greece and its efforts to bolster the local aviation industry and position Greece as a key aviation hub in Southeast Europe.

"Aegean and CAE bring their distinct expertise and knowhow to the joint venture, but they share common values when it comes to developing people. From the very beginning, Aegean's vision has been to add significant value to our country and the local aviation industry by giving our people the opportunity to sharpen their skills and reach their full potential," said Aegean CEO Dimitris Gerogiannis. "I am excited to see how the two teams come together to create a common culture of excellence at our new training center. This is an investment in the future of aviation. An investment that will grow our business and industry, but more importantly, will give limitless potential to our people."

Holding immense significance, as this year also marks ACE's 60th anniversary, the conference was held in Washington DC and Houston, Texas, on May 8-12, 2023, bringing together a delegation of ACE Executive Directors and representatives from the American Chambers of Commerce the opportunity to visit a number of prestigious government institutions, agencies, and administrations-including the US Chamber of Commerce, the Department of Commerce and State, and the Export-Import Bank of the United States (EXIM)-as well visit the NASA Space Center and meet with senior leaders from some of the largest US firms.

human effort, and also had the opportunity to meet with the Export-Import Bank and learn about funding programs and initiatives aimed at aiding US and European enterprises from Judith Pryor, EXIM's First Vice President and Vice Chair of the Board of Directors. This was followed by a visit to the US Department of State for a thought-provoking debate with Undersecretary of State Jose Fernandez, touching on a range of topics from unity to the Ukraine reconstruction mission, immigration policies, energy issues, and the Transatlantic Trade and Investment Partnership (TCC). Boyden Gray from the Atlantic Council's GeoEconomics Center; and Jon Decker, White House Correspondent and Senior National Editor at Gray Television. The Washington DC leg of the trip concluded with a highly productive meeting at APCO Worldwide that highlighted the immense untapped potential for business relationships between Europe and the United States.

Heading to Houston, Texas, the ACE delegation was welcomed by the Greater Houston Partnership, an innovative organization that promotes regional economic development, where Senior Director of Europe, Middle East, and Africa (EMEA) Jeffrey Blair underlined the importance of connectivity in Houston, a city with substantial aviation, road, rail, and broadband infrastructure that serves as a center for numerous sectors. The delegation also enjoyed the opportunity to meet with William Harris, President and CEO of Space Center Houston, and astronaut Reid Wiseman, who will be part of the Artemis Moon mission in 2025, and visited Collins Aerospace, a well-known aerospace company. The Houston leg of the trip also included visits to Honeywell, where the delegation met with Honeywell Process Solutions President Pramesh Maheshwari to discuss how the company pushes the boundaries of innovation while prioritizing environmental morality and individual wellbeing, as well as a visit to ExxonMobil's global headquarters, where they met with Romke Noordhuis, Executive, Global Business Solutions, Kurt Aerts, Director, Plastics and Product Life Cycle, and Filip Schittecatte, Industry Outlooks Manager.

Hybrid Work in Numbers

The hybrid work model seems to be here to stay and organizations the world over are finding ways to embrace it, defining policies and creating infrastructure to better navigate the intricacies of this new environment. As hybrid continues to evolve, new research is looking into what people value now and what has to change. work mostly remotely, those figures stand at 53% and 47% in the UK, 70% and 30% in Germany, and 95% and 5% in China.

2. SIZE MATTERS

We are seeing patterns emerging around who is adopting hybrid and where. Small and midsize companies in small and midsize cities tend to work in-office the most. Big companies in big cities, doing computer-based work, are adopting greater levels of

f all the changes and disruptions to our daily lives brought about by the global Covid-19 pandemic over the past three years, hybrid work is perhaps the most significant and longlasting, a fundamental rethinking of our relationship with the office that seems to be here to stay. Hybrid work is a flexible work model that supports a blend of in-office, remote and on-the-go work, affording employees the autonomy to choose to work wherever and however they are

most happy and productive. Importantly, hybrid work is still evolving and new patterns will keep on emerging as we continue to adapt to ever-changing conditions and developments—in the needs of the workforce, company culture, social norms, the business landscape and technology to name a few.

In this context, it would be interesting to know how hy-

brid work is faring around the world and how employees as well as organizations are responding to it. Recent global research by Steelcase, the global leader in office furniture and innovative workspace solutions, explored what people do, need and expect in today's era of hybrid work. The results are quite interesting.

1. THE OFFICE IS STILL KEY

On average, the majority of employees globally (70%) are working in the office at least three days a week. This number varies depending on a number of factors, including the line of work and the type of employer, as well as the country of residence. While in the US 55% work mostly in-office and 45%

hybrid or remote work. Based on Steelcase's research, 75% of employees in small companies work in-office compared to 69% in midsize and 60% in large companies.

3. IT DIFFERS BY INDUSTRY

Another key factor affecting the percentage of employees working in-office or remotely is the type of industry the company operates in. The industries with the highest per-

centage of employees working in-office are education institutions (87%), utility companies (84%) and manufacturing (80%), while the lowest percentages are found in telecoms (55%), tech (64%) and insurance (66%).

4. GENERATIONAL TRENDS

One of the most interesting outcomes from Steelcase's research is there is a correlation between age and preference for remote or in-office work, with the percentage of employees opting to work in-office standing at just 57% for Baby Boomers and 67% for Generation X compared to 73% for Millennials and 77% for Generation Z, who appear to be driven by a desire for better and faster career advancement.

Velos Rotors, a US-based incorporation with offices both in the USA and Greece, is specialized in designing and manufacturing top of the line unmanned helicopters in the 25 kg/55 lbs. class. Our main solution, Velos V3 is a low cost all-weather group 2 UAV that features a fully redundant twin engine design with IP65 certification, which can fly even in adverse weather conditions; case in point, Velos V3 is used by South Korea's coastguard for monitoring shorelines and lifesaving operations. In addition, our UAV is currently deployed by Ukrainian military forces in conflict areas.

The key to this transformation is the MQ-9B SeaGuardian remotely piloted aircraft system, which the United States, United Kingdom, Belgium, India, Japan, and others are turning to in order to expand their maritime domain awareness, connect their forces, and carry out some of their most

critical missions.

Adapted from the world's most proven family of remotely piloted aircraft, SeaGuardian does things nothing else can: It can fly for approximately 40 hours and was built from the wheels up to not only be certifiable but also for operations in non-segregated airspace, mixed in with everyday aviation traffic. Onboard sensors provide high-definition electro-optical or infrared video any time of the day or night; and an onboard radar sees through clouds, haze, smoke, or fog. The aircraft can also accommodate a growing number of specialized payloads to handle virtually any mission, on its own or in concert with other unmanned or manned units.

Critical to translating the data collected by the aircraft's onboard sensors into actionable intelligence products is General Atomics' Optix software suite. Optix allows operators to control multiple payloads simultaneously and generate intelligence products in real time with its TacSit-C2 module. These systems take the intelligence gathered by the SeaGuardian and interpret and distribute it seamlessly so that navies, coast guard agencies, border authorities, or others can decide and act better and quicker than ever before.

GREECE HAS THE OPPORTUNITY TO JOIN THE WORLD'S MOST ADVANCED NATIONS IN TRANSFORMING ITS MILITARY, INTELLIGENCE, AND SECURITY OPERATIONS

Old Threats, New Challenges and the Greek Defense Industry



Greece is situated in a conflict-prone region where the use of force is still considered an option by some neighboring revisionist powers. Greece relies on its strong Armed Forces and its participation in all West European security and political organizations to deter external threats and challenges. Therefore, the country historically spends a significant amount of its GDP on protecting its territorial integrity and vital interests. Defense procurements are cov-

This long-problematic mentality must change. New technology developments and the acquisition of cutting-edge defensive equipment must be accompanied by a shift in culture and strategy to support Greek defense industries. The central criterion of the choice of an industrial partner should not be the weapon itself but the transfer of technology and the technological knowledge that will form the basis for new dynamic development concepts that will cover the entire life cycle of the material under development as well as the production, control of certification, maintenance, modifications, improvements, and finally upgrades.

Greece needs to develop a sound and coherent strategy to work in favor of the Greek defense sector—not on its own, but through competent subcontracting with Greece's allies. The industry needs synergies. The strong relationships with the USA, must boost the prospects of the Greek defense sector and drive its growth.

Over the last decade, the Elefsina Shipyards have undertaken major repair projects to support and improve the field effectiveness of the Greek Navy and the Greek Fire Brigade and have created synergies with major companies in the field, such as the UK's Vosper Thorneycroft.

The prospects of the domestic defense industry, however, cannot flourish without the development of new production lines prioritizing the construction of all necessary equipment for the Greek Navy, from basic components to modern weapon systems. For this reason, We have established a strong cooperation network with the Italian shipbuilding behemoth Fincantieri and other companies in the field of technology—such as Leonardo, MBDA Italia, and Elettronica—aiming to create a domestic state-of-the-art production line for corvettes.

THE DEVELOPMENT OF DOMESTIC KNOWHOW AND TECHNOLOGICAL ADVANCEMENT IS AN ABSOLUTE PRIORITY

For ONEX Group, the development of domestic knowhow and technological advancement is an absolute priority. With this prime target, several Greek companies are actively participating in the above scheme, creating a strong industrial ecosystem around Elefsina Shipyards, being ready to undertake the crucial program for building the new naval corvettes. ONEX Group's vision demonstrates the development of a regional shipbuilding center in the Eastern Mediterranean with the mission to support the Greek fleet, as well as the warships of allied countries, offering advanced knowledge and high specialization and providing holistic solutions for the warship of the 21st century.



HONORING US LITERATURE

THE USA PAVILION AT TBF 2023

Returning to its regular format for the first time since before the pandemic, Thessaloniki International Book Fair came back with a bang and bigger than ever in 2023, with the United States as the honored country and an extraordinary USA Pavilion organized by AmCham Greece.

aying special tribute to US literature, the 19th Thessaloniki International Book Fair (TBF) took place on May 4-7, 2023, at the TIF HELEXPO Exhibition Center in Thessaloniki. Hosted across 14 halls, with a total of 14,000 sq. m., it featured more than 600 exhibitors and over 1000 speakers, from Greece and abroad, and included approximately 500 events, drawing roughly 90,000 visitors over its four days the Fair's highest turnout to date.

TBF 2023's extensive program included all things books—from book presentations, talks, workshops, and seminars to special themed highlights, dedicated areas for children's literature and young adult literature, and professional events featuring interna-

tional participation. Chief among the Fair's highlights this year was the participation of the United States as honored country and the USA Pavilion, which, at the Hellenic Foundation for Culture's invitation, was organized by the American-Hellenic Chamber of Commerce with the support of the US Embassy in Greece. In a statement on the Pavilion, AmCham Greece President Nikolaos Bakatselos stated: "Time and again, the American-Hellenic Chamber of Commerce continues to demonstrate the breadth of its contribution to supporting the bilateral ties between Greece and the United States. Following the hugely successful USA Pavilion that AmCham Greece organized at TIF 2018, today our Chamber's Culture Committee brings another hugely successful USA Pavilion to Thessaloniki, celebrating US literature at TBF 2023."

Aiming to showcase contemporary literary voices in US literature and highlight the United States book market through the participation of authors, commercial and academic publishers and university presses, and well-known cultural and literary figures, the effort was spearheaded by the Chamber's

Culture Committee, with the Combined Book Exhibit tasked with coordinating the participation of US authors and publishers. In total, the USA Pavilion featured more than 20 major publishers, including Abrams, Georgetown University Press, Harvard University Press, Macmillan, Merriam-Webster, MoMa, Penguin Random House, University of Chicago Press, and Yale University Press—as well as thirty smaller publishers, micropublishers and authors.

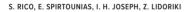
"We believe in the power of books; we believe in the power of culture to build bridges and to bring together people, nations and states," said AmCham Greece VP Vassilis Kafatos at the Pavilion's official inauguration, where he performed the ribbon cutting ceremony joined by the Chamber's own Zozo Lidoriki, Chair of the Culture Committee; Litsa Panayotopoulos, Treasurer and Chair of the Education, Innovation and Entrepreneurship Committee; and Elias Spirtounias, Executive Director; alongside Eleni Doundoulaki, Secretary General for Contemporary Culture at the Ministry of Culture and Sports; Nikos Koukis, President of the Hellenic Foundation for Culture; Salina Rico, Deputy PO at the US Consulate General in Thessaloniki; Tasos Tzikas, President of TIF HELEXPO; and Konstantinos Zervas, Mavor of Thessaloniki.

"AmCham Greece is a chamber of commerce, but we believe that culture is an important tool in diplomacy—whether it is political, economic or commercial—and we also have a particularly active Culture Committee, so we felt it was our duty to rise to the Hellenic Foundation for Culture's invitation and organize this Pavilion," AmCham Greece Executive Director Elias Spirtounias.

"This is a fantastic opportunity for Greek books and Greek literature to come into contact with publishing houses and authors from across the Atlantic—but also the other way round—and in this way to develop new synergies and new collaborations in this field," said Secretary General for Con-

temporary Culture Eleni Doundoulaki, going on to add that "this is all happening in the context of a broader partnership between Greece and the United States that has emerged and has been dynamically evolving over the past years, with open dialogue and collaboration in matters of culture, both heritage and contemporary."

"Having an honored country is very important, as much for Thessaloniki International Fair as for industry-specific exhibitions such as Thessaloniki International Book Fair," noted TIF HELEXPO President Tasos Tzikas, referring to the USA's participation as honored country at TIF 2018, and underlining the lasting positive impact that continues to have in the city.

"Until now, Thessaloniki Book Fair was impressive, with an excellent cultural program, but the international aspect wasn't as pro-

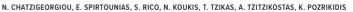

"Books allow the mind to travel the world," the Ambassador said, stressing the power of books to broaden horizons and enlighten readers. "Education is very important to Greeks. It has been a cornerstone to a better life. And the materials of education are books and reading," he explained. Ambassador Tsunis went on to praise the AmCham Greece's efforts in organizing the USA Pavilion and stress that the relations between the US and Greece are today better than ever.

Over the course of the four days, book enthusiasts and industry professionals alike were treated to an outstanding celebration of the US's contribution to contemporary literature and culture-both at the USA Pavilion and across the Book Fair in general. The audience had the opportunity to hear and interact with a host of US authors-including Ismini Lamb, Claire Messud, Meg Rosoff, Saskia Vogel, James Wood, and Nell Zink, who were invited by the Hellenic Foundation for Culture-and to attend more than 20 parallel events focused on US literature. A further three literary agents from the United States attended Thessaloniki International Book Fair as part of the Fair's brand new Thessaloniki Book Fellowship initiative, which launched this year with 20 publishers and agents from 16 countries around the world.

Following the end of the Book Fair, the American-Hellenic Chamber of Commerce donated the 608 books that had been on display at the Pavilion, distributing them among five recipients across Thessaloniki: a newly established refugee library, the 2nd General High School of Stavroupoli, the American Farm School, Anatolia College, and Thessaloniki TechLab.

The USA Pavilion at the 19th Thessaloniki International Book Fair marked the first time ever that the United States was featured as the honored country in a major book industry event in Europe. Highlighting the far-reaching, multilevel ties between Greece and the US across sectors and fields, including literature and culture, it inaugurated new channels of cooperation and opened new perspectives in the international book market.

DESTINATION GREECE

ALL ROADS LEAD TO RHODES A NEW PREMIER DIGITAL NOMAD DESTINATION IN THE SOUTH AEGEAN

In spring 2023, tech heavyweight Cisco partnered with Greece's South Aegean Region for an initiative to establish the Greek island of Rhodes as a top haven for digital nomads, sending a group of Cisco employees from across Europe to live and work from the island and explore the impact of digital nomads on the local economy.

eading global technology company Cisco, in collaboration with the South Aegean Region, launched an initiative to establish Rhodes as a prime global hybrid work destination. The initiative involved a hosting program that saw 17 Cisco employees from all corners of Europe travel to Rhodes and spend three months—March 2 to May 31, 2023—working remotely from the breathtaking Greek island. This pilot program successfully showcased Rhodes as a smart digital island and an enticing destination for global remote workers.

The project's key objective was to establish relationships of mutual cooperation and nurture a fulfilling experience for all parties involved by integrating Cisco's highly qualified, tech-savvy employees with local organizations and the local community. Cooperation and co-innovation are integral components of Cisco's Country Digital Acceleration Program (CDA), a program designed to encourage digital research and education and stimulate digital entrepreneurship.

Last year, Cisco embarked on an innovative venture in Venice to reimagine the future of hybrid work and transform work, workplaces, and communities by accommodating work-fromanywhere employees. Sixteen Cisco employees were given the opportunity to live and work remotely in Venice for three months as part of the Venywhere project. This year, focusing on regional development, Cisco partnered with the South Aegean Region to commit resources and expertise and set Rhodes on the path to becoming one of the most sustainable destinations globally, using CISCO's digital technologies.

This venture provides exciting opportunities for regions and destinations offering a high quality of life—such as Rhodes, with its beautiful locales, natural environment, and rich cultural heritage—and the Rhodes Digital Nomads project builds on this to bring forth meaningful transformation.

The advent of work-from-anywhere capabilities is significantly altering the landscape of destination growth. In addition to focusing on attracting businesses, destinations can now also thrive by engaging individual talented workers. These locations can serve as distributed workspaces, providing individuals with greater flexibility and establishing a better work-life balance.

The sustainability of the new working model lies to a large extent in the wellbeing of employees and the ability to create and produce in an environment that fosters the growth of soft and digital skills. During these three months, Rhodes became the ideal destination for remote work, with the local society and economy at the forefront of interest for the effective implementation of digital transformation.

The 17 digital nomads worked out of four traditional co-working spaces across the city of Rhodes, namely the K2 Development Agency, the Chamber of Commerce and Industry of the Dodecanese, the South Aegean Region headquarters, and the city's Museum of Modern Greek Art.

Rhodes has a vision to attract not just tourists but digital nomads who can help shape a new type of citizen. Greece makes concrete investments to attract remote workers, with their Digital Nomads Visa. Rhodes' ambition to create a sustainable future for its citizens resonates perfectly with our company's purpose to power an inclusive future for all.

A LONE IN A CROVD

What is the individual's position in relation to society? Where do the personal and communal intersect? How does apartness shape experience? A new exhibition by the Hellenic American Union and Athens Pride 2023, uses visual art to explore the concept of individuality in today's world. rom Thursday, May 25 to June 24, 2023, Athenians and visitors to the Greek capital will have the opportunity to visit the group visual arts exhibition Alone in a Crowd, which will be hosted at the Hellenic American Union's Hadjikyriakos-Ghikas Gallery at Massalias 22, in the heart of the city.

Organized by the Hellenic American Union in conjunction with Athens Pride 2023, and curated by art critic Andrea H. Gilbert, the exhibition invites twelve visual artists—Antonakis, Despina Christou, Alexandros Georgiou, Mark Hadjipateras, Alex Kat, Marilia Kolibiri, Andreas Lyberatos, Deanna Maganias, Alexandros Simopoulos, Angel Torticollis, Theo Vranas, and Maria Zervos—working in a variety of media, to examine the concept of individuality in today's world.

"Alone in a Crowd explores the position of the individual in relation to the social whole," notes Gilbert in her introduction to the exhibition catalogue. "Twelve artists navigate the emotional and physical intersections of the personal and the communal, the private and the public, as well as manifestations of interiority and exteriority – across a tortuous, often inhospitable, terrain. They explore the conditions of solitude, isolation, and alienation to reveal that this apartness is not necessarily, or exclusively, painful. ALONE IN A CROWD PARTICIPATING ARTISTS

Chatting with a Chatbot

Rapid technological advancements and an ever-increasing capacity to automate and streamline work processes are transforming industries across the board.
